A. SAFETY ASSESSMENT

The Safety Assessment has been carried out according to the Cosmetic Regulation n° 1223/2009 and its amendments.

GFL SA with Registered Office in Lugano, Via Sorengo n°1, 6900 (CH), is responsible for the preparation of P.I.F. (Product Information File) and for notification of Cosmetic Bulk (C.P.N.P: Cosmetic Product Notification Portal) through the website authorized, for all Cosmetic bulk indicated in the table above.

and are available at any time to the Italian & EU Authorities.

The safety assessor of PIF files and their continuous improvement is Dr. Corinna Bergomi, based at GFL Srl, at the above address.

As indicated above, all product supplied by GFL SA with Registered Office in Lugano, Via Sorengo n°1, 6900 (CH), must be considered fully in compliance with the current regulations.

B. COSMETOVIGILANCE

Cosmetic products developed and distributed by GFL on the EU market have high standards of safety and quality. The undesirable effects due to normal use or reasonably foreseeable use are rare, light-weight nature and fully reversible. However, as required in compliance with EU Regulation, the PIF is constantly updated and revised in the event of change of raw materials or reports of side effects from the end user, including their registration and evaluation in order to understand their nature and prevent for the future

More, no animal test has been carried out on any ingredients used in GFL's Cosmetic product after 11th March 2009, for the purpose of the European Cosmetics Regulation)EC) n° 1223/2009

F. NO ANIMAL ORIGIN

GFL SA with Registered Office in Lugano, Via Sorengo n°1, 6900 (CH) declares that its cosmetic products don't contain any ingredients from animal origin.
Only in some specific products can be used secondary derivatives (example: natural extracts of honey)

G. GMOs (Genetically modified Organisms)

GFL SA with Registered Office in Lugano, Via Sorengo n°1, 6900 (CH) declares that in its knowledge its cosmetic products don't contain any ingredients from Genetically modified organism (GMOs).

H. NANOMATERIAL

I. COLOURS

GFL SA with Registered Office in Lugano, Via Sorengo n°1, 6900 (CH) declares that all colours used in tis cosmetic bulk are in compliance with Commission Directive 2008/128/EC (specific purity criteria for use in foodstuffs)

J. GMP

GFL SA with Registered Office in Lugano, Via Sorengo n°1, 6900 (CH) declares to follow G.M.P. (Good manufacturing Practices). GFL SA also declares that Company GFL Srl, whom manufacturers for GFL SA, is following good manufacturing practices. In support to this we received the IFS certification which covers the requirements of the GMP for Cosmetics.

K. REACH

GFL SA with Registered Office in Lugano, Via Sorengo n°1 , 6900 (CH), does not manufacturer or import substances and, as distributor of cosmetics and other toiletries for Hotels, SPAs and facilities of the adjacent sectors, is not subject to the requirement of REACH registration of their products.
